Human Rights Advocacy for Women in Afghanistan

- 1- Peace and prosperity are the phenomena that Afghan citizens have longed waiting for. Peace is not merely a shutdown of war (which has not been realized under Taliban control). It is not possible to realize the peace of the people in Afghanistan with the hegemony of Sharia law and rule based on descent. Afghan citizens want peace in Afghanistan where they will not have to pay off the Taliban in order to survive, and for women's freedom thoughts not to be violated by their captivity and civil rights.
- 2- Recognition of the Taliban's Islamic Emirat means recognizing the continuation of people's suffering in Afghanistan and for women. In addition to seriously calling for the failure to recognize the Taliban's Islamic Emirat and the end of Talibanism, we strongly demand that Taliban representatives and leaders be brought to international courts as war criminals. And this anti-human rights government will never be recognized.
